County Assessor Patti Milligan told the board she has been getting a lot of phone calls regarding the valuations that went out earlier this month due to the increases. Senator Myron Dorn was also present and spoke regarding the valuations and tax relief in the form of income tax credit that the Legislature is working on. It won't show on your property tax statement but will show on your income tax statement as a tax credit. He said that a lot of things go into the equation and that more work will be done, it just takes time. He mentioned that there are other hot issues such as workforce and daycare, saying that the employment rate in Nebraska is at 70% compared to the national average of 62%, which creates more of a need for daycare providers.

Patti stated that her office is required by law to be at a certain percentage of valuation so if she didn't raise valuations to meet that criteria then she would be ordered to go to TERC (Tax Equalization Review Committee).

Tiemann said he wanted to clarify that the Assessor's Office only sets the property valuation, not the property taxes.

Senator Myron Dorn spoke to the board under public comments. He said that he wanted to give more numbers from the State perspective regarding what they've changed over the last couple years so that people understand it. The changes don't affect valuations but they provide property tax credits and/or income tax credits to give consumers some tax relief in that way. He said there are 10 entities listed on your tax statement such as the County, City, Schools, etc., that receive a portion of your property taxes based on their levy and valuations. The levies and valuations are set each year so they change each year, and you get a statement at the end of the year of the amount you will pay the next year. In 2002, the State did a property tax credit of about \$50 million and that has grown over the years. That amount will increase each year and by 2029 it will be up to \$550 million in tax credits. It also has a rider that if valuations go up 3% or more, the property tax credit fund will also go up by 3%. The tax credit you receive will show on your property tax statement as a negative number right above the total due on your tax statement, and it is automatically credited right off your property taxes – you don't need to do anything to receive it! The counties are then reimbursed by the State for that amount of money. The amount credited should average between 5-7% of your property taxes that you will receive back. Dorn said there is another part of the property tax credit fund that is credited on your income tax statement. It is based on the amount of school taxes you pay and it comes off of your state income tax due, but you must apply for this credit. The credited amount came to about 25% of the average person's school tax if you owe income tax, and if you don't owe income tax a check was sent out as a refund. Dorn said that when the Federal charts with property tax relief data come out and they show where Nebraska sits, it is deceiving because this income tax credit is not included in those charts as it doesn't count as property tax relief since it's applied to your income tax. This year, only about 2/3 of the \$550 million available for this credit was claimed, as in many cases the fee to apply for it was about the same as the credit so people didn't apply. As the amount available increases each year, it will become more advantageous for people to utilize. Also, you have 3 years to go back and claim the credit if you didn't apply for it in the first 2 years. Dorn said the Legislature is trying to move away from everything being set on how we value things. Sen. Erdman had 2 bills that affect TERC (Tax Equalization & Review Commission). One increased the number of adjusters from three to four, and funded them with more money. The second read that if you were up at TERC for longer than one year and they didn't rule on you, your valuation would revert back to the original previous amount. This was added as an amendment to LB243, but there was a question as to whether the State could change or set the valuation at that point. The Attorney General was consulted but there wasn't enough time to get a ruling from him, and if the whole bill passed with the amendment included, then a ruling was made against the amendment, the whole LB243 Bill would be no good, so the amendment was pulled. He said depending on the ruling of the Attorney General, the amendment could be back again next year. Another thing Dorn wanted to touch on was SCC. A year ago, they passed LB873 where the State would pick up a portion of SCC taxes for all 6 community colleges, increasing each year over 5 years, up to about 2/3 of their total property taxes. This year there was a proposal to come back and pick it all up and there were some agreements reached with the community colleges. In LB243 this year, the State said they will pick up all of the SCC property taxes, and they will be refundable as a credit on your income tax, however, SCC raised their levy up to the highest amount allowed of 9% due to the increase in valuations. Therefore, this first year, the taxpayer will have to pick up half of the SCC taxes, and in two years the State will pick up the full amount. Dorn anticipates there will be something done to address what SCC did, as there are a lot of people unhappy about it.

Haxby joined meeting at 8:42 a.m.

Senator Dorn said he also wanted to take a minute to publicly thank Emily Haxby for what she's done for the State of Nebraska. She challenged all our location points of where Broadband Internet is in the State, and the State is going to get \$400 million, and she is specifically the reason why we got another \$13 million in that funding because they were not going to challenge anymore, but she continued to challenge more and got the extra funding. There will also be more funding in the future years and she was a very important part of that, and he wanted to really thank her for the work she did, not only for the county, but also for the State. That amount of Federal funding will have a tremendous impact on the State of Nebraska.

Tiemann asked Sen. Dorn if he could address school taxes. Dorn said schools do their own, and depending on the school district it could be more or less, but it averages across the state at around 60% of taxes that go to schools.

Motion made by Swavely, seconded by Lytle to open public hearing at 8:49 a.m. to approve or disapprove tax exemption on vehicle(s) owned by Mosaic. Motion carried 6-0.

No public present.

Motion made by Swavely, seconded by Lytle to close public hearing at 8:50 a.m. Motion carried 6-0.

Motion made by Swavely, seconded by Lytle to approve tax exemption on vehicle(s) owned by Mosaic. Motion carried 6-0.

Chairman declared Board of Equalization adjourned at 8:54 a.m. until July 12, 2023.



## Gage Board of Equalization Minutes



The Gage County Board of Equalization met on July 12, 2023 at 8:33 a.m. with Terry Jurgens, Emily Haxby, Don Schuller, Erich Tiemann, Eddie Dorn and Dave Swavely present, Gary Lytle absent. Patti Milligan, County Assessor, present.

Notice of said meeting was posted at the County Clerk's Office and published prior to the meeting in compliance with State Statutes.

Let the record show that all proceedings are electronically recorded.

Chairman Tiemann announced that a complete copy of the Open Meetings Act is posted at the back of the Board of Supervisors Room.

Motion made by Swavely, seconded by Dorn to approve the agenda as presented. Motion carried 6-0.

Motion made by Dorn, seconded by Swavely to approve the minutes of the previous meeting as mailed/mailed out. Motion carried 6-0.

No public present for comments and request for future agenda items.

Recessed at 8:35 a.m. until 1:00 p.m. for property valuation protests.

The Gage County Board of Equalization reconvened at 1:03 p.m. with Terry Jurgens, Emily Haxby, Don Schuller, Erich Tiemann, Eddie Dorn, Dave Swavely and Gary Lytle present. Patti Milligan, County Assessor, and appraisers/referees Darrel Stanard and Lloyd Dickinson also present.

Several people who had filed property valuation protests appeared at the meeting to discuss the recommendations being presented to the board on their property valuations. Those speaking were: Joe Armstrong, Tanya Malchow, David Rayburn and Robert Newby. Each person speaking was sworn in prior to speaking.

**Joe Armstrong:** 1250 Lakeview Lane, Beatrice NE, parcel #005218108 – Joe was on the list for no change with a value of \$839,820.00. He had comparable cost per sq. foot of homes in the same area and of comparable style that were significantly lower than his. He requested a value of \$681,566.00. After Joe visited with Darrel Stanard about the differences in value between comparable homes, Darrel recommended a value of \$733,660.00. This protest was originally on the list for no change and was just accidentally not switched over to the list for changes due to the late timing of the decision. Motion made by Haxby, seconded by Dorn to move parcel #005218108 to the change list with the valuation set at \$733,660.00. Motion carried 5-1-1 with Jurgens voting nay and Tiemann abstaining due to conflict of interest.

**Tanya Malchow:** 405 N Sumner St., Beatrice NE, parcel #001800000 – Tanya stated that she is being taxed on 80 acres but she only owns 62 acres. Lloyd said that Spruce Road cuts into her land and splices off a part of it. Since there was a discrepancy in the number of acres, Tiemann asked if they could do some checking on and/or adjusting of acres and come back to her later in the meeting. She agreed.

**David Rayburn:** 100 W Mulberry, Beatrice NE, parcel #014683000 – David asked why he had an increase of 10% last year and 14% this year when he hasn't changed anything, and what homes they used as comparables. Milligan explained the State requirements and how they use sales to determine values. Stanard explained that there is now a covered patio that wasn't ever added to the valuation, and that the protest was on the percentage of increase, not on the valuations of comparables and there were no comparables provided. Milligan said that if she had not made the changes by percentage then the State would've ordered her to do it that way. She also pointed out that it would be impossible to physically go look at and research comparables for over 16,000 properties in one year so they have to come to a percentage of increase across the board, but she did offer to go research some comparables, show him the sales book, and explain further how they come to the percentages. She said that her job is to put the increases on to be at the required percentages of valuation, but it's the taxpayer's responsibility to prove that they're wrong by finding comparables that show they are out of place, and we can also look at what's going on in the marketplace. She also said that they don't "chase" sales, they treat the sold and unsold properties of similar type the same. Tiemann said that there is nothing they can do at this point to change this year's valuation, but that with help from the Assessor, they can possibly find evidence to help in the future.

**Robert Newby:** 11746 W Pine Rd., Diller NE, parcel #001464000 – wanted to know why his building went up just under \$14,000. Lloyd explained that it's a sales-based system per the law, so the Assessor knows what that type of property is selling for, what it's currently assessed at, and when it gets out of alignment

the State of NE says you have to raise everybody by a certain percentage. Newby said he just wants to know how they came to that amount. Tiemann gave him a copy of the calculation sheet that the Assessor used that Lloyd will go over. Lloyd explained that they looked at several comparable properties' valuations and figured the price per square foot, and Newby's was right in line with what the Assessor had. Swavely said that the Assessor looks at properties of similar size, condition and age and then has to use the information that is available to come to a decision. Lloyd pointed out that the comparables he used were all in the area of Newby's home. Newby said he just wanted to find out how they came to the valuation and Tiemann said that if he still has questions, to talk to the Assessor and/or Lloyd. No change was made.

Tiemann asked to return to the Malchow property. Lloyd said they came up with 65.32 deeded acres for her property, and the property across the road to the North would have 82.57 acres. Lloyd said they would need to refigure for an amount. Tiemann said they would refigure and get a new amount and asked if Malchows could come back at the July 24<sup>th</sup> meeting. They said they could do that so the protest on this parcel will be heard on July 24<sup>th</sup>.
